National Pingtung University Student Dormitory Regulation

Passed by the 1st Student Affairs Committee Meeting of the 2nd Semester, Academic Year 103, on March 16, 2015.

Passed by the 1st Student Affairs Committee Meeting of the 1st Semester, Academic Year 110, on January 13, 2022.

Passed by the 1st Student Affairs Committee Meeting of the 2nd Semester, Academic Year 112, on June 6, 2024.

- 1. In order to improve the quality of student dormitories, maintain order and safety, the University hereby establishes this Student Dormitory Regulation (hereinafter referred to as "the Regulation") in accordance with the Student Dormitory Self-Governance Regulations.
- 2. The University dormitory has set up an official Facebook fan page named "國立屏東大學學生宿舍" for information sharing and communication.
- 3. Dormitory management staff may enter rooms for maintenance and inspection when necessary for management or safety reasons. Workers entering the dormitory must wear identification vests.
- 4. If students use a personal combination lock on the dormitory room, it must be registered at the front desk. Otherwise, repair services may be affected. Unregistered locks may be forcibly removed by dormitory staff if required for management or safety.
- 5. Regulations for the use of bathroom and sanitary facilities:
 - (1) Residents should avoid using the bathrooms during peak hours and use hot water during designated supply times (5:30 p.m. to 12:00 a.m.) to maintain proper supply.
 - (2) Residents must comply with the designated times and usage instructions for washing machines and dryers, and may not move them arbitrarily.
 - (3) Users of bathrooms and public cleaning facilities should observe etiquette and maintain cleanliness, restoring the facilities to their original state after use.
 - (4) Energy conservation should be observed by avoiding waste of water and electricity (e.g., do not use hot water for laundry; turn off lights and faucets when leaving).
- 6. Dormitory facilities and equipment may not be removed for external use. After use, all facilities must be returned to their original place and kept clean. Damaged equipment must be compensated at cost.
- 7. Personal belongings (e.g., shoes, garbage) may not be placed in public areas (e.g., lounges, hallways). Violations will be cleared and handled according to regulations.
- 8. Broadcasting hours are from 12:00–12:30 p.m. and 7:00–8:00 p.m. Exceptions may be made for emergencies. For personal matters, residents should use internal phones or contact individuals directly to avoid disturbance.
- 9. Clothing must be dried in designated areas according to dormitory regulations. Violations will be strictly prohibited.
- 10. Approved posters may only be displayed in designated areas. Posting inside the dormitory is prohibited, and flyers may not be placed in room mailboxes.

- 11. If dormitory beds become vacant due to various circumstances, the dormitory management may adjust or consolidate room assignments to optimize resource use and save energy.
- 12. The exhaust fan in dormitory rooms operates on 220V power; other appliances must not be connected to avoid damage.
- 13. For safety reasons, only low-energy appliances such as hair dryers, radios, fans, mosquito repellers, and computers are allowed. High-energy appliances such as microwaves, induction cookers, and rice cookers are strictly prohibited.
- 14. Playing musical instruments, gambling, setting off firecrackers, or engaging in activities that disturb peace or safety are strictly prohibited inside dormitories.
- 15. Cooking is prohibited in the dormitory, except in areas specifically designated by the management.
- 16. Drinking alcoholic beverages and gambling are strictly prohibited in the dormitory.
- 17. Smoking is strictly prohibited inside the dormitory.
- 18. The dormitory will be closed during winter and summer breaks. Rooms must be cleared, and power sockets unplugged according to regulations.
- 19. Students who need accommodation during breaks must apply according to the announced schedule by submitting an application form. Regulations and fees will follow the University's Dormitory Application Guidelines.
- 20. Bicycles and motorcycles must be parked in designated student parking areas. Parking near or inside the dormitory is prohibited.
- 21. Drawing or carving on dormitory walls is prohibited.
- 22. Consumable items in the dormitory (e.g., network cables, extension cords, remote control batteries) must be prepared by residents themselves.
- 23. This Convention shall be implemented after approval by the Student Affairs Committee.
